The Hirer will remain liable for all unpaid charges and the Official Contractor may apply, and retain all or a portion of the Hirer's security/ damage deposit as may be necessary to compensate the Official Contractor for any unpaid charges or damages and expenses incurred on account of default; the Official Contractor may exercise any other rights occurring to a hirer under any applicable law upon a default by the Hirer.
